### ASBESTOS INITIAL TRAINING

- Asbestos Maintenance Worker Initial \$315
  - Also known as Class III or O & M Training (Operations & Maintenance)
  - Who Needs this Training? Maintenance/custodial staff, electricians, HVAC technicians, plumbers, etc.), who may work in a building public or commercial, or a school that contains asbestos.
  - In this 2-day course workers will cover regulations regarding this type of limited asbestos-related work, history, & uses of asbestos materials in buildings, potential health effects, personal protection, engineering controls & response actions, & methodologies for abatement & disturbance during routine maintenance activities.
  - <u>Regulations:</u> 40 CFR 763.92(a)(1)-(2), 40 CFR 61, 8 CCR 1529

### Asbestos Worker Initial \$495

- <u>Who Needs this Training?</u> Maintenance/custodial staff, electricians, HVAC technicians, plumbers, etc.), abatement laborers.
- This four-day course is accredit and covers many topics including safety, laws and regulations, and state-of-the-art work procedures. The participant will also be involved in hands-on training which will include activities such as donning personal protective equipment, building a decontamination unit, glove-bagging, and proper use of common asbestos abatement equipment and tools. Prerequisites: None
- Regulations: 40 CFR 763, 8 CCR 1529, 40 CFR 61, 40 CFR Appendix C to Subpart E

- Asbestos Contractor/Supervisor Initial \$695
  - Required for CAC & CSST Certifications
  - Who Needs this Training? Supervisors & Competent Persons who will engage in the work or will be directly responsible for the overall supervision of employees in relation to its asbestos abatement activities.
  - This course will cover how to perform abatement activities for a response action other than a SSSD activity, a maintenance activity that disturbs friable asbestos other than a SSSD activity & a response action for a major fiber release episode.
  - Regulations: 40 CFR 763, 8 CCR 1529, 40 CFR 61, 40 CFR
     Appendix C to Subpart E

### Asbestos Project Designer Initial \$600

- Required for CAC Certification
- Who Needs this Training? Any person who intends to design any of the following activities with respect to friable ACBM in a school or public and commercial building: 1) a response action other than a SSSD maintenance activity, 2) a maintenance activity that disturbs friable ACBM other than a SSSD maintenance activity and/or 3) a response action for a major fiber release episode.
- This course includes lectures, demonstrations, a field trip, course review and a written examination.
- <u>Regulations:</u> 40 CFR 763, 8 CCR 1529, 40 CFR 61, 40 CFR Appendix C to Subpart E

- Asbestos Building Inspector Initial \$550\*
  - Required for CAC & CSST Certifications
  - <u>Who Needs this Training?</u> All persons who want to be able to inspect for Asbestos Containing Building Materials (ACBMs) in schools or public and commercial buildings.
  - The course is focused on lectures and hands-on training conducting a simulated sample collection and inspection, and includes respirator and other personal protective equipment use.
  - Regulations: 40 CFR 763, 8 CCR 1529, 40 CFR 61, 40 CFR Appendix C to Subpart E

### Asbestos Management Planner Initial \$330\*

- Required for CAC Certification
- Who Needs this Training? All persons who prepare management plans for schools must be accredited and take this course.

- This course includes lectures, demonstrations, course review, and a written examination.
- Regulations: 40 CFR 763, 8 CCR 1529, 40 CFR 61, 40 CFR Appendix C to Subpart E

### LEAD INITIAL TRAINING

- Lead Inspector/Assessor \$750 (40 hrs)
  - Requires State Exam & Annual Certification Fees to become fully certified by CDPH.
  - In this course students study & put into practice HUD protocols for inspecting facilities for lead coatings & for assessing hazards posed by lead. Students learn about paint chip sampling and its analysis by atomic absorption, and about the principles of x-ray fluorescence (XRF) testing and use state-of-the-art XRF analyzers in the field.

### Lead Awareness \$100\* (2 hours)

- <u>Who Needs this Training?</u> Supervisors, Construction Superintendents, Project Managers, etc.
- This course is for employees who are working in proximity to lead, but not directly with lead. The also covers general knowledge of hazards associated with lead exposure & requirements to reduce or eliminate exposure.
- Requires at least two (2) hours, whether or not they are required to work with the lead.
- Regulation: 8CCR 1532.1, Lead Appendix B

### FEDERAL EPA LEAD RRP INITIAL

- Federal EPA Lead Renovation, Repair & Painting Initial Training \$200 (8 hrs)
  - Who Needs this Training? Any contractor, including renovators, electricians, HVAC specialists, carpet installers, window installers, plumbers, painters & maintenance staff, who disrupt more than six square feet of lead paint in pre-1978 homes, schools, day care centers & other places where children spend time.
  - Refresher Training Required every 5 years. <u>There is NO</u> <u>Grace Period.</u>
  - Contractors are subject to steep EPA fines if training & Firm Certification) is not met.
- <u>EPA Firm Certification</u> must be completed separately from the training via the EPA website. <u>The cost per firm</u> certification is \$300.
- This course was developed to train renovation, repair, and painting contractors how to work safely in housing with lead-based paint and comply with EPA's RRP Rule, and HUD's Lead Safe Housing Rule.

### HAZWOPER INITIAL TRAINING

### 40 hour HAZWOPER \$695

- Who Needs this Training? This course is designed for site workers involved in the investigation, clean-up & removal of hazardous waste, & other activities which expose or potentially expose workers to hazardous substances or health hazards.
- The course features lectures to help workers learn about hazard awareness, hazardous waste regulations, exposure and medical monitoring, health and safety planning, respiratory protection, personal protective clothing, monitoring and sampling equipment, site characterization and control, decontamination, and emergency response.
- <u>Regulation:</u> 8 CCR 5192(e)(3)(A)

### 24 hour HAZWOPER \$495

- Who Needs this Training? Workers who are only onsite occasionally for a specific limited task (such as, but not limited to, ground water monitoring, land surveying, or geo-physical surveying) & who are unlikely to be exposed over PELs and published exposure levels.
- This course covers identification of personnel & alternates responsible for site safety & health; safety, health & practices to minimize risks from hazards; safe use of engineering controls & equipment on the site; medical surveillance requirements; and site safety and health plans, etc.
- Regulation: 8 CCR 5192(e)(3)(B).

- Regulation: 29 CFR 1910.120(q)(6)(ii) and 29 CFR 1926.65(q)(6)(ii)

## **OSHA FOR CONSTRUCTION**

### OSHA 10 for Construction

- 2-day course (cannot be held in (1) single day)
- <u>Who Needs this Training?</u> Supervisors, Construction Superintendents, Project Managers, etc.

- Respiratory Protection & Fit Testing

  - Per 1910.134(k), requires the Employer to provide effective training to employees who are required to use respirators. The training must be comprehensive, understandable, and recur annually and more often if necessary. The employer is also required to provide the basic information on respirators in Appendix D of this section to employees who wear respirators when not required by this section or by the employer to do so.

### Safety At Heights (Fall Protection)

- <u>Who Needs this Training?</u> Employers shall provide a training program for each employee who might be exposed to fall hazards. Training shall enable each employee to recognize the hazards of falling & shall train each employee to minimize these hazards.
- This course covers the Cal/OSHA Fall Protection Standard for construction and an overview of fall protection methods. Course topics include principles of safety at heights/ fall protection, components and limitations of fall arrest systems, and OSHA Standards and policies regarding fall protection. Students will participate in workshops demonstrating the inspection and use of fall protection equipment, residential construction fall protection, training requirements, and developing a fall protection program.
