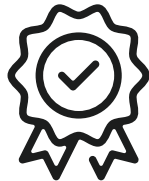

#### #1002 - Asbestos Worker Initial (32 Hours) \$495

This 4-day Cal/OSHA accredited course covers safety, PPE, laws, regulations, & hands-on training required to perform abatement activities (containment, glove bag, & more).

#### #1016 - \*CDPH Lead Related Construction Supervisor/Project Monitor Initial (40 Hours) \$675

In this 5-day course, students will learn how lead abatement is performed in a variety of settings, how to safely handle lead materials during construction projects and how to select appropriate abatement actions for varying field conditions. State Exam and Certification is required to perform lead abatement supervisor activities in California.

In this 5-day course, students study & put into practice HUD protocols for inspecting facilities for lead coatings & for assessing hazards posed by lead. Students learn about paint chip sampling and its analysis by atomic absorption, and about the principles of x-ray fluorescence (XRF) testing and use state-of-the-art XRF analyzers in the field. State Exam and Certification is required to perform lead abatement Inspector Assessor activities in California.
